A4 paper size, set format 16 x 24.5 cm (page size: top margin 2.9, bottom margin 2.9, left margin 2.5, right margin 2.5, header 2.2).

The following styles must be set in order to create a page design:

Main text style: Times New Roman, font size 12 point, single line spacing, 1.25 cm indent, automatic word transfer, alignment to width (automatic only! no spaces, tabs, etc. allowed in this case)

Heading style - bold, 12 point, Times New Roman, centred, not indented.
